Andrew Johnson represents individuals and companies in cases involving products liability, professional liability, premises liability, general casualty, and commercial disputes. Andrew frequently handles proceedings and appeals involving the Texas Citizens Participation Act (Chapter 27 of the Texas Civil Practice and Remedies Code, also called the Anti-SLAPP statute), the Certificate of Merit statute (Chapter 150 of the Texas Civil Practice and Remedies Code), special appearances challenging personal jurisdiction, and post-appraisal motions in insurance disputes. He also often argues before courts of appeals.

Before Thompson Coe, Andrew worked as a staff attorney at the Fourteenth Court of Appeals of Texas. While at the court, he wrote well over 100 proposed opinions, including in complex civil appeals.
