# Background

Before joining the firm, Steve served as a Judge Advocate in the U.S. Army. During his last three years there, Steve was responsible for prosecuting members of international terrorist groups under the Military Commissions Act in Guantanamo Bay, Cuba. In that role, Steve's efforts resulted in the first conviction of a High-Value Detainee for war crimes. They helped bring another high-profile capital terrorist case closer to a conclusion, which had been pending for more than ten years since litigation commenced.

Before his work as a prosecutor, he represented more than 300 soldiers accused of violations of the Uniform Code of Military Justice before all trial courts and administrative boards in the Army. During the war, he also served as the chief legal advisor to a commander of 4,000 soldiers in Kandahar, Afghanistan. Before his military career, Steve managed a successful solo law practice focusing on civil and criminal litigation, which included representing individuals, corporations, and indigent criminal clients. With this diverse range of clients, Steve can handle most matters.
